

Privacy Policy

Updated February, 2016

Allergan respects your privacy. This website ("Site") collects only the personal information that you choose to provide, and Allergan uses your personal information only for the purposes of running this website and providing the services described in the website. Allergan will not sell, share, or otherwise distribute your personally identifiable information to third parties for their purposes. Allergan shall at all times process your personal data in compliance with all applicable law and regulations. Please read our full policy and let us know if you have any questions or concerns.

How We Collect Information

Allergan recognizes your need for appropriate protection and management of personal information you share with us (personal information means any information you have provided by which you can be identified, such as your full name, e-mail address, professional address (including city and post code), title and role in the clinic, telephone number, etc.). The purpose of this privacy statement is to inform you what personal information we may collect from you when you visit our Site, and how we use such information, and the choices you have regarding our use of, and your ability to review and correct, the information.

In general, you can visit many of our Web pages without telling us who you are or revealing any personal information. We may track the Internet domain address from which people visit us and analyse this data for trends and statistics, but individual users will remain anonymous, unless you voluntarily tell us who you are.

If you choose to provide us with information about yourself, such as your full name, professional address (including city and post code), title and role in the clinic, telephone number, e-mail address, etc., we will respect the trust that you have placed in us. Whether or not to provide such information is completely your own choice; Allergan collects only the personal information that you provide to us. But if you choose not to provide the personal information we request, you may be unable to access certain services, offers, and content on our Site.

How We Use Information We Collect

We use the information which is automatically received from your Web browser to see which pages you visit within our Site. Such information is used to develop statistics that are helpful to understanding how this Site is used by our visitors. This statistical data is interpreted by Allergan in its continuing effort to present the Site content that visitors are seeking in a format they find most helpful.

When Allergan receives personal information, we will only use it for the purposes for which it was collected such as for Registration, Online access to the services. If you e-mail us, you are voluntarily releasing information to us. Your e-mail address will be used by Allergan to respond to you, if you have asked Allergan to do so.

Third-Party Use of Information

Allergan will not sell, share, or otherwise distribute your personally identifiable information to third parties except as provided herein and in accordance with applicable laws and regulations.

Allergan does not share your personal information with third parties for their marketing purposes; so there is no such sharing to opt-out of.

Personal information may occasionally be transferred to service provider third parties who act for or on behalf of Allergan, or in connection with the business of Allergan, for further processing in accordance with the purposes for which the data was originally collected within the EU. We require that such third parties protect the personal information and, where appropriate, we will contractually require them to process data transferred only for the purposes expressly authorized by Allergan and if transferred to the United States of America, under a valid transfer mechanism.

In case of a security breach or pursuant to a legal matter that requires cooperation with authorities, your identity and the personal information you provide may be used for investigation purposes, in accordance with the applicable laws and regulations. Whereas applicable, Allergan may also remove all the personal information and use the rest for historical, statistical, or scientific purposes.

Cookies

To enable Allergan to provide customized and personalized services, Allergan may use cookies to store and sometimes track information about you. A cookie is a small amount of data that is sent to your browser from a Web server and stored on your computer. Cookies, by themselves, do not tell us any personal information about you. However, if you choose to furnish the Site with personally identifiable information (such as your e-mail address), that information could be linked to the data stored in the cookie.

Children

In order to respect the privacy of children online, we do not knowingly collect, maintain, or process personal information submitted by children under the age of 18. If you have a child under the age of 18 who you believe may have provided personal information to us, please e-mail us at privacy@allergan.com and we shall expeditiously delete it.

Internet Information Security

We take reasonable precautions to ensure that any personally identifiable information you provide on this Site is kept confidential and stored in a secure environment, and that only those personnel with legitimate business purposes will have access to this information. In addition, Allergan guarantees that personal data provided to us will not be subject to loss, alteration, misuse, unauthorized access, disclosure, or destruction. Notwithstanding the foregoing, you should safeguard any passwords or special types of identification you use to access this Site.
